WELCOME!

Welcome to the National Conference in Pediatric Psychology! A national meeting has become essential to the development of the pediatric psychology field, to the improvement of science and services for pediatric patients and their families, and to our collective futures. This conference carries on the traditions of scientific and clinical relevance in presentations and interactions well established by the University of Florida going back to its first conference in 1988. Conferences in Charleston and Miami confirmed the value of a national gathering of pediatric psychologists. Regional conferences similarly have provided valuable venues for professional interaction.

With this conference, the Society of Pediatric Psychology has assumed fiscal responsibility for our national meeting on a biennial schedule. After other institutions had developed and maintained conferences, it became untenable to ask local organizations to carry the financial risk and effort of holding a conference of this magnitude. We also thank the American Board of Clinical Child and Adolescent Psychology and RTI International for their co-sponsorship of the meeting. We have been able to keep the registration fees as low as possible through the sponsors' donations—the field should appreciate their foresight to support this conference through generous fiscal contributions.

Our goal for this conference is to provide pediatric psychologists and trainees with an overview of the most current research in many of the cross-cutting areas that we address as clinicians. Thus, with input from the Conference Advisory Committee we selected topics for plenary addresses and symposia that would inform clinical practice across many specific populations. Our hope is for attendees to benefit from thinking about these cross cutting issues in the context of both familiar and unfamiliar conditions and populations.

In addition to these cross-cutting plenary sessions and symposia, the program benefits from an array of posters on a very wide range of topics. You will notice that we have distributed topics across all 5 of the poster sessions, and have grouped topic areas within poster sessions. Thus, you will find posters on most topics in each of the sessions. We anticipate that the many members of SIGs at this conference can use this organization of the posters to facilitate discussion within and among group members within the poster sessions.

In addition to the substantive programming, we have arranged for meetings of the *Journal of Pediatric Psychology*, several newly developed Special Interest Groups, and the American Board of Clinical Child and Adolescent Psychology. Two receptions will facilitate dialogue on significant issues in research and practice. The Mentoring Lunch on Saturday, organized by the SPP Student Board, provides opportunities for interactions between trainees and established pediatric psychologists.

Organizing a meeting of this size requires substantial efforts by a large number of individuals and groups. We are indebted to the SPP Board, the Conference Advisory Committee, the Scientific Review Board, and our student assistants for their partnership with us in the development of the conference.

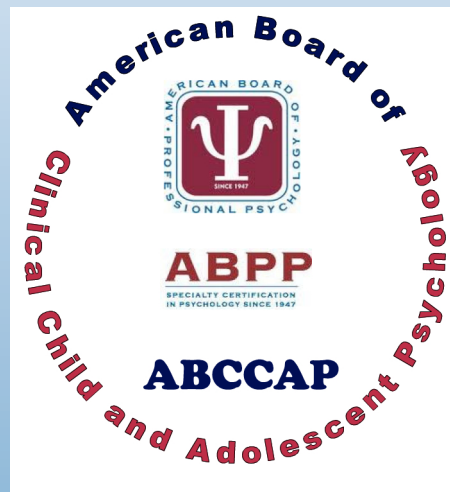
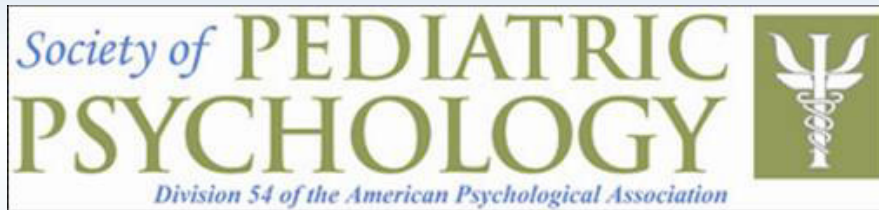
