## WELCOME!

Welcome to the National Conference in Pediatric Psychology! A national meeting has become essential to the development of the pediatric psychology field, to the improvement of science and services for pediatric patients and their families, and to our collective futures. This conference carries on the traditions of scientific and clinical relevance in presentations and interactions well established by the University of Florida going back to its first conference in 1988. Later conferences in Charleston, Miami, Gainesville, and San Antonio confirmed the value of a national gathering of pediatric psychologists (each with 500 participants!). Regional conferences similarly have provided valuable venues for professional interaction first established by the “North Coast” group in 1987.

With the 2011 conference, the Society of Pediatric Psychology assumed fiscal responsibility for our national meeting. We start conferencing on an annual schedule with this year (and next year’s conference will be in Philadelphia). We also thank the American Board of Clinical Child and Adolescent Psychology for its co-sponsorship of the meeting. We have been able to keep the registration fees as low as possible through the sponsors’ donations.

Our goal for this conference is to provide pediatric psychologists and trainees with an overview of the most current research in many of the cross-cutting areas that we address as clinicians. Thus, we selected topics for plenary addresses and symposia that would inform clinical practice across many specific populations. We are responding to attendees’ feedback from the San Antonio meeting in 2011 by formalizing CE opportunities for the Special Interest Groups (SIGs) and creating three concurrent symposia scheduled for Saturday. Also, based on feedback, we worked to lower student registration fees and not significantly raise regular registration rates.

In addition to the cross-cutting plenary sessions and symposia, the program benefits from an array of posters on a very wide range of topics. We received an amazingly large number of poster and symposium proposals. You will notice that we have distributed topics across all 5 of the poster sessions, and have grouped topic areas within poster sessions to facilitate discussion on the poster topics.

In addition to the substantive programming, we have arranged for meetings of *Clinical Practice in Pediatric Psychology*, the new SPP journal, and the *Journal of Pediatric Psychology*, the Special Interest Groups, and the American Board of Clinical Child and Adolescent Psychology. Two receptions will facilitate dialogue on significant issues in research and practice (Thursday and Friday evenings). The Mentoring Lunch on Saturday, organized by the SPP Student Advisory Board, provides opportunities for interactions between trainees and established pediatric psychologists (lunch is provided for all registered attendees). We also note that the Student Advisory Board provided the students who will be introducing the speakers at the conference.

Organizing a meeting of this size requires substantial efforts by a large number of individuals and groups. We are indebted to the SPP Board, the Conference Advisory Committee, the Scientific Review Board, the SPP Student Advisory Board, the University of Kansas Division of Continuing Education, and our student assistant for their partnership with us in the development of the conference.

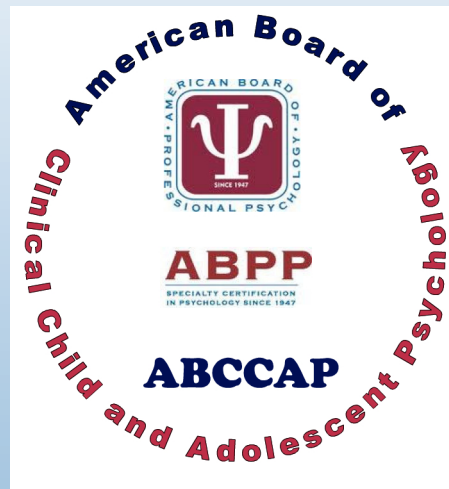
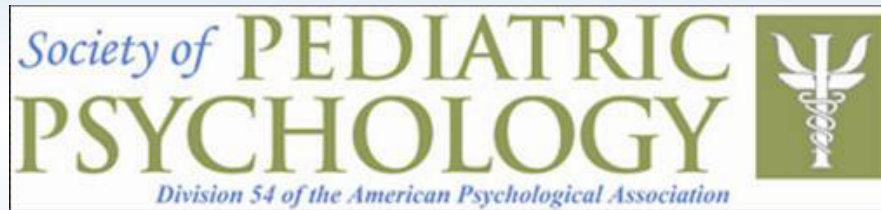
